



Krav Maga Northern Beaches (KMNB) Terms and Conditions

1. Health Waiver:

Prior to the first class, the Health Waiver must be completed at:

Medical clearance is required for conditions impacted by training.

2. Obligations upon Joining:

All students are required to purchase the KMNB uniform and any equipment as advised at the time of joining.

3. Child Supervision:

Parents and Guardians are responsible for Child Members outside the scheduled class times. KMNB is not responsible for children who are unsupervised outside their scheduled class times.

4. Membership Payments:

Membership fees are paid weekly by credit card or other agreed payment method. Membership debits continue until you notify us otherwise.

Members are responsible for ensuring that there are sufficient funds in the nominated accounts.

Members agree to bear all costs of reversed transactions or unsuccessful debit attempts.

Members are responsible for keeping their payment details up to date.

KMNB reserves the right to suspend a membership for non-payment of membership fees. KMNB may continue to debit your nominated account until any debt is paid in full.

5. Temporary Holds on Membership:

KMNB understand that from time to time a member may not be able to train temporarily due to sickness, injury, travel, or other unforeseen circumstances.

Any request to place a membership on a temporary hold must be made in writing and include the name of the member the hold applies to and the beginning and

end date of the hold period. All hold requests must be emailed to:

Hold requests must only be submitted by email. Any requests made in person or by phone will not be processed.

Membership fees will not be processed during a hold period.

6. Membership Cancellation Policy:

Memberships may be cancelled at any time with a minimum 30-day notice period.

If memberships with a 'minimum term' are cancelled ahead of the expiry of the minimum term, 75% of the total value of the membership fees for the remainder of the minimum term must be paid prior to the cancellation date.

Any request to cancel a membership must be made in writing and include the name of the member the cancellation applies to, the date of the cancellation and the reason for the cancellation. All cancellation requests must be emailed to: info@kravmaganorthernbeaches.com.au.

Cancellation requests must only be submitted by email. Any requests made in person or by phone will not be processed.

Payments scheduled to occur during the 30-day notice period will be processed as usual.

7. Refund Policy

Payments for memberships and workshops are non-refundable. Class credits may be offered for personal or medical reasons at the discretion of management.
